

## Photovoltaic Modules and Inverters 2023 and 2024 Fee Schedule

### EPEAT Participating Manufacturer Fee Effective for New and Renewing EPEAT Participating Manufacturers

Payment of the Participating Manufacturer fee below enables a manufacturer to engage in the EPEAT Program. The fee for this product category covers photovoltaic modules (including modules for installation on, or integral, with buildings, and modules primarily used as components of free-standing power-generation systems) and photovoltaic inverters (including PV-string inverters with included maximum power point trackers, central inverters, micro inverters, bi-directional inverters, and a combination of a DC optimizer plus the inverter in systems where both are necessary).

EPEAT Participating Manufacturer fees are for one year, beginning on the date of enrollment. The fees below apply both to new and renewing manufacturers. The fee is required to be paid annually.

Engaging a Conformity Assurance Body (CAB) is required as part of EPEAT participation. Fees for CAB services are not included in the EPEAT Participating Manufacturer fee.

The EPEAT Participating Manufacturer fee is based on the Participating Manufacturer's most recent annual global sales of their branded products, stated in U.S. dollars. Global sales include all types of photovoltaic modules and photovoltaic inverters covered by the Photovoltaic Modules and Inverters category (as defined above), whether or not those products meet EPEAT Criteria or are actually listed in the EPEAT Registry.
