WHO IS COMMITTING?

The Global Electronics Council (GEC) Climate+ Pledge is made on behalf of an organization and is supported by its senior leadership. Organizations that sign the pledge will be recognized as **EPEAT® Climate+ Purchasing Advocates.**

WHAT ARE YOU COMMITTING TO?

1. SETTING TARGETS

Aim to inspire organizations and individuals across industries to prioritize EPEAT Climate+ products in their procurement decisions. By fostering awareness, collaboration, and measurable goals, GEC aspires to drive widespread adoption of environmentally responsible technology and reduce carbon emissions.

The pledge commitments are set to encourage greater adoption of climate-minded and sustainable technology products:

The following are required commitments for the pledge:

- Actively advocate for EPEAT Climate+ designated products within their sectors and professional communities.
- Educate others in their sector or organization about the environmental benefits of EPEAT Climate+ designated products.
- Participate in collaborative initiatives and campaigns to promote climate-friendly electronics.

2. REPORTING PROGRESS

Sending a signal about the power of sustainable procurement to mitigate climate change by transparently reporting against the Pledge commitments to GEC. Collective progress will encourage others to make similar commitments, helping organizations demonstrate their global impact on sustainability.

GEC takes privacy and data security seriously. GEC will only publicize your information disclosed with prior approval. GEC may share purchasers' data in anonymized and aggregated form, meaning that all identifying information has been removed so that individual data or information of a signatory cannot be associated with that individual or entity without extraordinary effort. This helps GEC better understand trends and patterns while safeguarding the privacy of pledge participants.

Annual Progress Reports on the Following are Required:

- Establish or adapt existing purchasing guidance highlighting the benefits and importance of
 electronics with reduced climate impacts, with specific reference to Climate+ designated products
 within six months of signing the pledge. Send a copy of the guidance to GEC.
- Engage in two or more community, industry or network events to promote EPEAT Climate+ and sustainable purchasing. Provide GEC with a summary of these activities annually.
- Collaborate with two or more organizations or entities on EPEAT advocacy projects or initiatives. Provide GEC with a summary of these activities annually.
