Global Electronics Council® Climate+™ Pledge

WHO IS COMMITTING?

The Global Electronics Council (GEC) Climate+ Pledge is made on behalf of an organization and is supported by its senior leadership. Organizations that sign the pledge will be recognized as **EPEAT® Climate+ Purchasing Leaders**.

WHAT ARE YOU COMMITTING TO?

1. SETTING TARGETS

Leveraging the organization's purchasing power to mitigate climate change by prioritizing EPEAT Climate+ designated products and increasing total IT spending towards sustainable electronics.

The pledge milestones are set to encourage increased total annual IT spending toward climate-minded and sustainable technology products:

The following commitments are required for the pledge:

- Require EPEAT® registered products in contracts and/or purchasing policies. **
- Show a preference for EPEAT registered products with the Climate+ designation in purchasing guidance. **
- Annually quantify energy use savings and carbon reductions from the purchase of EPEAT registered products with the Climate+ designation by using the EPEAT benefits calculator.

2. REPORTING PROGRESS

Sending a signal about the power of sustainable procurement to mitigate climate change by transparently reporting against the Pledge commitments to GEC. Collective progress will encourage others to make similar commitments, helping organizations demonstrate their global impact on sustainability.

GEC takes privacy and data security seriously. GEC will only publicize your annual spending report or other information disclosed with prior approval. GEC may share purchasers' data in anonymized and aggregated form, meaning that all identifying information has been removed so that individual data or information of a signatory cannot be associated with that individual or entity without extraordinary effort. This helps GEC better understand trends and patterns while safeguarding the privacy of pledge participants.

Annual Progress Reports on the Following are Required:

- Calculate the carbon emissions reduction achieved by purchasing EPEAT registered products using the EPEAT benefits calculator. Report to GEC annually.
- Assess and report on the reduction in energy costs by purchasing EPEAT registered products using the EPEAT benefits calculator. Report to GEC annually.
- Increase in the adoption of EPEAT Climate+ designated products. Report goals and outcomes to GEC annually.
